



2025 AFRAM National Conference





SEIU International President April Verrett spoke to the attendees and highlighted a lot of really important challenges we have in front of us and coming up on the horizon, but the one message that I can't stop thinking about and wanting to share is simple, and yet



still so profoundly critical of what we are here for. April said that she wants to make sure that every one of our members can afford to go grocery shopping. The kind where you don't have to stick to a strict list

on a razor tight budget. She wants our members to be able to go grocery shopping while they are hungry and not have to worry about cutting into their rent money, their bill money, their credit cards! That's what brought Unions together in the first place, and it's what keeps us together still to this day.



At this year's conference we had panels discussing how important it will be to bring a culture of militancy to our movement. Now is not the time to shy away from taking risks, standing up against unfair treatment and fighting for our members' rights, and all workers' rights! These members are Starbucks workers from California who were so invested in their fight that they were arrested for "making good trouble." They now wear that as a badge of honor because in 2024, after two and a half years, they were successfully able to get Starbucks to agree to go to the table with them, in over 400 stores for more than

10,000+ workers. When we fight, we win! Adopting a culture of militancy will be how we get there.

Scholarship Application Deadline is May 23rd

The deadline for the SEIU 517M - Tomorrow's Michigan Today Scholarship is Friday, May 23, 2025. The scholarship is open to dues-paying members in good standing (as defined in the SEIU Local 517M Constitution and Bylaws), their spouse, children, step children, adopted children or grandchildren with college or trade school expenses.

There are 15 scholarships available and the amount of each scholarship is \$600. These non-renewable scholarships will be awarded to students based on successful completion of the application process and meeting certain criteria. Tech Notes - News for Technical Unit Members

Technical Unit Challenges MDOT Subcontracting

Grievances have been filed under our contract and civil service challenging the subtracting of technical unit jobs. The current authorization was to supplement technical unit work, and not replace state civil service Technicians. Technical unit jobs have been lost in Detroit as the department continues to send work to contractors. The grievances were denied by MDOT at Step Two and appealed to OSE and Civil Service. The Civil Service grievance has been appealed to the Employment Relations Board after the Civil Service Hearing Officer denied a hearing on this matter. More to the story on the website.

Technical Unit Appeals Claim to Circuit Court

The Technical Unit Grievance Committee voted to file a claim in Circuit Court to overturn an Employment Relations Board decision that denied the Leave to Appeal by bargaining unit members challenging MDOT's policy and application of overtime balancing under the Civil Service Rules and Regulations. The claim was filed after MDOT changed their policy on the balancing of overtime opportunities. More to the story on the website.

Long Term Disability Claim Denied

A long-term member has been denied her LTD claim. We are working with her to appeal the denial from Sedwick to the Employee Benefits Department in accordance with the Civil Service Rules and Regulations. We are in the process of obtaining all the documents needed for this appeal.

Failed Drug Tests

We have had some positive random drug tests recently. If you are in a drug test designated position, please remember that just because cannabis is legal in the State, it is still prohibited to be in your system if you are in a test designated position.

DNR Forestry & Wildlife - Denied Use of Annual Leave vs Comp Time

A Forestry Tech working for the DNR who is certified as a Forest Firefighter was denied the ability to use annual leave before accrued comp time. The Technical Unit Contract and FLSA allow for public safety and seasonal workers to use vacation time before comp time if their levels of annual leave are greater than 250 hours. Since seasonal workers are required to work a large amount of overtime/comp time, the contract allows to provide them the ability to use their annual leave to avoid having to lose hours as they reach closer to the cap. The department is claiming that fighting forest fires is not done "regularly" and the technicians are considered volunteers. More to the story on the website.

Labor-Management Meeting on Safety Standards

DTMB Radio Tech Unit Rep David Peck raised concerns about safety standards not included in the assignment of new work vehicles. A meeting was held regarding safety cages or barriers between the driver and the rear cargo areas of trucks and SUV's. Previous assigned vehicles had safety cages so in the event of an accident or roll-over, tools boxes and radio tower components will not hurl through the vehicle unrestrained potentially causing injury or death.
