Feeding Communities: Boxes on Break in Saginaw

Boxes on Break began with a simple question Clint Bryant asked himself: What more can I do for my community? Already known for giving his heart and soul in service to others, Clint turned that question into action, focused on supporting children during school breaks.

For many students, school provides consistent meals, and long holiday breaks - especially the two-week stretch over Christmas and New Year's - can be especially challenging for families facing food insecurity. Boxes on Break was created to help fill that gap.



Over the holiday break, volunteers packed and distributed more than 800 boxes for school children in Saginaw, each filled with cereals, snacks, soups, and other essential items. These boxes offered more than food - they provided peace of mind, stability, and care during a critical time.

SEIU Local 517M was a proud sponsor of this initiative, helping turn compassion into meaningful support for local families. Boxes on Break is a powerful reminder of what's possible when one person's idea and a community's commitment come together to make a difference.

The SEIU API Caucus community stands united from the West Coast to the East Coast and everywhere in between. In solidarity!

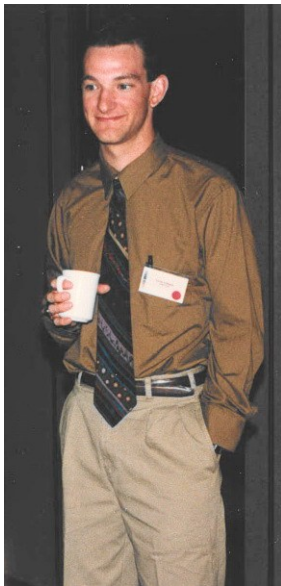


Long Time Staff Member Announces Retirement

After thirty-six years with SEIU Local 517M, Dave Corrie has advised the Local that he will be retiring on February 13, 2026.

Dave began his career on October 4, 1989, as part-time clerical help at the Michigan Professional Employees Society (MPES) —the original name for SEIU Local 517M only representing the Scientific and Engineering bargaining unit. He continued in this role while attending Lansing Community College and Michigan State University.

Upon graduation from Michigan State with a degree in Human Resources, he was retained as a full-time staff representative in July 1993.



During his years of service, he has held many roles. His full-time duties after graduation were that of a staff representative handling grievances, arbitrations, technical appeals and Civil Service subcontracting challenges. He also participated in two bargaining cycles. As the least senior staff representative he was responsible for publishing the MPES newsletter.

His role with MPES changed in 2000. Local 517M began growing through mergers of other SEIU and independent locals. The workplace was changing with the increased use of technology. With the management and building of computers, running the email system, continuing to publish the newsletter, and creating and maintaining a website, there was enough work to focus full-time on communications and technology. He also started handling the Scientific and Engineering Professional Development Fund. During this time, he served as the technologist for the SEIU Michigan State Council and Change to Win in Michigan.

During his years he has been active with the Michigan Labor Press Association which provides training for union communicators. He has served on their Executive Board as a Board Member and as Secretary.

“It has been an honor to uplift and assist our membership over these past 36 years”, said Dave. “I have been blessed to work with great members and staff -- it has truly become a family.”
